# From the Desk of Gil Fonger

President & CEO



Dear Marklund Family,

As we approach the 71st anniversary of our founding—marked by the birth of our first resident, Mark William Lund, on December 21, 1954—we reflect on how far Marklund has come. From our modest origins, we have grown into a large, missiondriven nonprofit dedicated to serving children and adults with serious and profound developmental disabilities.

As of the end of 2025:

- We employ 514 dedicated staff members
- We support 181 residents, 27 community clients and 95 students
- We provide services across 4 locations: 1 in Geneva, one in Bloomingdale, and 2 in Elgin
- Over the past 12 years, we have completed over
- \$45 million in capital expansions/renovations.

- We operate 4 Marklund Day Schools offering MultiNeeds and LifeSkills programs
- We deliver Community Day Services both onsite at our residential locations and offsite through the Bridge Builder CDS program
- Our current budget stands at \$53.5 million

Managing an organization of this scale and impact is a responsibility we take seriously. Since 2012, our leadership has been guided by strategic plans developed collaboratively by our Board of Directors and many key stakeholders. The current plan— Serving the Underserved-Together—focuses on five key priorities:

- 1. Investing in Our Staff Our people are our greatest asset. We are committed to strengthening recruitment and retention efforts.
- 2. Expanding Care We are seeking to pioneer a new model of group homes and create 24/7 ventilator care in Elgin, while also broadening our offsite Community Day Services program.
- 3. Securing Our Future We are expanding our fundraising strategies and launching new events to ensure long-term sustainability.
- 4. Enhancing Community Engagement We aim to elevate brand awareness, deepen community relationships, and grow our volunteer program.
- 5. Advancing Educational Impact We are optimizing the structure of our day schools, enhancing special education services, and investing in staff development.

Each of these priorities is supported by a comprehensive three-year roadmap. I'm proud to share that, thanks to the dedication and hard work of our team, we've already made significant progress.

At the heart of everything we do is a steadfast commitment to our mission of making everyday life possible for individuals with profound disabilities and our vision of a happy, safe and purpose-filled life for every individual with intellectual and developmental disabilities.

Our goal remains clear: to ensure that Marklund continues to be a strong, sustainable organization that meets the evolving needs of those we serve today and will serve in the future—just as our founders envisioned more than seven decades ago.

# A Conversation with \_\_\_\_\_ Hope Schmidt

Hope joined Marklund in October 2020 as an Occupational Therapist (OT) for the Day School in Geneva. She currently serves residents and students at both the Wasmond Center and Nathan Education Center in Elgin, supporting individuals

Occupational Therapist, Registered and Licensed (OTR/L)

with differing diagnoses of Autism and Cerebral Palsy. With a vibrant personality and a deepening expertise in occupational therapy, Hope brings creativity and enthusiasm to every session. Her innovative approaches include using sensorybased techniques, imaginative Point-of-View activities to teach new skills, fostering independence through aquatic therapy, collaborating with recreation therapists during community outings, and evaluating and ordering customized hand and wrist splints.

"I knew I wanted to be an OT since I was 16 years old; when I was babysitting a little boy with Autism who was undergoing therapies through Early Intervention. At the time, OT just looked FUN to me!"

### What made you get involved in healthcare?

I have always been interested in and passionate about devoting my time to serving others in need. I originally imagined myself working in the hospital setting; however, it was during my time in OT school throughout fieldwork experiences that I realized I prefer a setting in which I can build greater relationships with my patients and not be limited to how I provide my services (billing guidelines, patient quotas, etc.).

## What attracted you to Marklund?

After I researched about Marklund, I was impressed about several things: first it was a nonprofit, and I wanted to be a part of an organization with a strong mission. Then, I learned Marklund hires therapists, not just contracts with outside therapists. I wanted to find a career and position that I loved and could grow in. When I saw it had an opening in their day school, although I was passionate about working with the older population, I also love working with the younger population...seeing students grow so much over the past 5 years and gain many new skills is so rewarding.

# Best part of your job is

Being part of individuals' "everyday life," is the essence of my profession as an occupational therapist. One particular, recent event that stands out in my mind is a young student of mine who, with supportive seating and an adapted feeding utensil, just recently fed herself for the first time in her life!

# Favorite memory so far from your work at Marklund?

My favorite memory has to be spending the

day at the Museum of Science and Industry with a resident from MWC during a group recreational therapy outing. Her permanent smile, exploring the exhibits, navigating the crowd, and giggling at the nuances of the day while taking in and managing all the sensory stimulations etched a core memory for me.

# What would you say to a therapy professional considering taking a job

I would encourage them to grab the opportunity – The Therapy team is so wonderful and very supportive. Marklund has helped shape me into the OT I am today; wellrounded, confident and motivated!

# A ribbon cutting event celebrates

On a late afternoon this past fall, staff, board members, donors and honored guests gathered of people and together to celebrate the newly expanded and renovated Marklund Wasmond Center residential facility and school for individuals with developmental disabilities.

The \$17.4 million project included a 일 20,000-square-foot addition and took approximately 18 months to complete.

This is the finest facility in Illinois serving individuals with medically complex 6 developmental disabilities," said Gil Fonger, Marklund President and CEO. "It features state-of-the art equipment to help provide very specialized 24-hour care to adults and children, combined with spacious, modern living and visiting areas.

Among the speakers at the September 11th event was IL State Sen. Cristina Castro, and a member of Congresswoman Delia Ramirez's staff. Members of the Marklund Board of Directors and major donors to the project's capital campaign took part in the official ribbon cutting, that was then followed by tours of the facility.

Sen. Castro thanked Marklund for continuing the vision to meet the needs of those in this population. "You have been the cornerstone for many suburban families with the newly expanded center here in Elgin which is another investment in enhancing the lives

futures with developmental disabilities in our communities. As one of just 8 organizations statewide providing specialized services for those living with profound

disabilities and complex medical needs, the impact of an additional 20,000-square-foot expansion cannot be overstated. I want to thank you again for the extraordinary work you do day in and day out to support your residents' dignity, independence and sense of community.

Magda Herron, on behalf of Congresswoman Ramirez, noted that the Congresswoman stated she is grateful to have an organization/ facility like this in her district, and presented a letter of commendation for the board of directors and the management team.

"We are very proud to have developed this incredible facility on this location to continue to expand upon its history within the Elgin area, while we continue to meet our mission—our promise—to make everyday life possible for individuals with profound

disabilities," Fonger added. "Like our founders back in the 1950s, it is in our DNA to go toward the need-the need to serve those seeking the very specialized care we can provide

- Additional 24 beds, bringing the total to 85
- Each bed will be fully Vent Capable 24/7
- New Recreation Room
- 2 Additional Nurses Stations
- 2 New large, Private Living Room Areas for parents/guardians to visit with their loved ones
- 2 Accessible Courtyards including sensory garden
- More than double the number of Parking Spots to 131
- More restrooms for staff & visitors

- Dedicated Therapy Area including onsite aquatic therapy pool
- Additional Marklund Day School classroom bringing total to 3
- Increasing the number of new or renovated Community Day Services classrooms to 7
- Renovated Community Day Services multipurpose room
- New paved sidewalks around entire building and connecting to adjacent neighborhood
- Dedicated storage and receiving areas

# A History in Elgin The Marklund Wasmond Center originated in 1958 as

Little Angels Center for /Exceptional Care when Nurse Pat Wasmond, her husband, Bob, and their children began providing care in their home to children with profound disabilities. Their home was located on the property where the Wasmond Center is situated. Expansions and renovations occurred over the years, then in 2016, the Little Angels board made the decision to merge with Marklund. The building was renamed the Marklund Wasmond Center to honor the legacy of care started by its founders.

# Marklund's December Appeal



At the top of a slope, skis strapped to an adapted sled, Peter was ready. It wasn't the summit that daunted his parents, it was everything it took to get there. This symbolized the life they had worked so hard to pursue for Peter: one without limits. Peter has cerebral palsy. His disabilities affect every part

of life and all activities of daily living. His mom, Cathryn, shared that "from the beginning, it's been about partnering with great people and organizations to remove barriers and support Peter in developing his strengths to succeed and live as independently as possible."

As Peter grew, his parents wondered how they would continue to meet his needs, and how disability would affect their hopes and dreams. His dad, David, shared that "we did our best every day, knowing there was a long road ahead." Encouraged by their therapy team to set no limits, they poured themselves into his early development. "We ran really hard with therapies and treatments in the early days... I think Peter is where he is now because of that early investment and support he received," Cathryn said.

Caregiving became more physically and emotionally demanding, extending to Peter's two younger brothers. His parents sought balance through family adventures. Skiing became a symbol of possibility.

"We've tried to push the boundaries with Peter, to create as many opportunities, experiences, and memories as we can," Cathryn said. But pursuing these came at a personal cost.

When they lost a longterm caregiver, the family hit a breaking point. "Our 8 Christian faith and the



disability ministry at church was an anchor for our family." Still, they knew they would need a transition to residential placement. They were not familiar with Marklund, but a high school field trip with one of their other sons brought them for a visit. Cathryn was struck with a powerful and emotional realization: "Here are our people. This could be Peter's next step toward independence." Partnering with Marklund meant finding trusted residential support to ensure Peter's needs would be met, while finding a place of peace and encouragement for his family.



Before Marklund, Peter's parents were extreme caregivers. Now, they can focus on being mom and dad again.

"I'd say he's my hero... Peter gets up every day with so many challenges, but finds joy in life," said David. This is the life many of our Marklund residents live. Your holiday gift ensures individuals like Peter receive the support they need, while helping families breathe, reconnect, and thrive. Your generous support is an investment in people's lives. 
### What do you admire most about the Marklund mission/vision?

# Holiday Giving

# Stocking Up on Impact

Has your stock portfolio seen growth over the last year? Giving appreciated stock (held for over a year) can be a win-win and is one of the most tax-smart ways to give. By donating stock directly to Marklund, you potentially avoid capital gains taxes, while receiving a charitable deduction—making your gift go over 20% further than a cash donation.



# Simplify Giving with a Donor Advised Fund

Donor advised funds have gained popularity in recent years, allowing individuals at various income levels to streamline their charitable efforts. A sort of philanthropic piggy-bank, donors can contribute cash, stocks and other assets to these funds within sponsoring organizations. This allows for tax free growth of all assets within the fund, allowing donors time and space to develop a giving strategy and thoughtfully select charitable organizations, like Marklund!

### Over 70½? Make Your IRA Work for Good

If you're 70½ or older, you can make a Qualified Charitable Distribution (QCD) - a direct gift from your IRA to a nonprofit like Marklund. In 2025, you can give up to \$108,000 this way, and it won't count as taxable income or require itemizing deductions. If you're 73 or older, these gifts can also help satisfy your Required Minimum Distribution (RMD).

When determining which giving strategy works best for you, Marklund encourages you to speak with your tax advisor or other financial professional. As always, we are grateful for your friendship and support. Wishing you and yours a happy holiday season.
